

AMERICAN POWER CONVERSION LIMITED FACTORY WARRANTY FOR TRANSIENT VOLTAGE SURGE SUPRESSOR

The limited warranty provided by American Power Conversion (APC[®]) in this Statement of Limited Factory Warranty applies only to products you purchase for your commercial or industrial use in the ordinary course of your business. The limited warranty is without prejudice to any rights that you may have under the applicable law.

Terms of Warranty

American Power Conversion warrants its Transient Voltage Surge Suppressor ("Surge Protector Product") to be free from defects in materials and workmanship for the duration of the applicable warranty period¹. APC obligation under this warranty is limited to repairing or replacing, at its sole discretion, any such defective products. Repair or replacement of a defective product or part thereof does not extend the original warranty period. Any parts furnished under this warranty may be new or factory- remanufactured.

Non-transferable Warranty

This warranty applies only to the original purchaser who must have properly registered the product. Product may be registered at <u>warranty.apc.com</u>.

Exclusions

APC shall not be liable under this warranty if its testing and examination disclose that the alleged defect in the Surge Protector Product does not exist, or that it was caused by the end user's or any third person's misuse, negligence, or installation, testing, operation or use of the product contrary to APC's recommendations or specifications. Further, APC shall not be liable for defects resulting from: 1) accidents, 2) unauthorized attempts to repair or modify the product, 3) incorrect or inadequate electrical voltage or connection, 4) inappropriate on-site operation conditions, 5) Acts of God, 6) exposure to the elements, 7) change in location or operating use, 8) start-up by non-APC designated personnel or 9) theft. In no event shall APC have any liability under this warranty for any product where the serial number has been altered, defaced, or removed.

EXCEPT AS SET FORTH ABOVE, THERE ARE NO WARRANTIES, EXPRESS OR IMPLIED, BY OPERATION OF LAW OR OTHERWISE, OF SURGE

THE WARRANTIES SET FORTH ABOVE CONSTITUTE APC'S SOLE LIABILITY AND PURCHASER'S EXCLUSIVE REMEDY FOR ANY BREACH OF SUCH WARRANTIES. APC'S WARRANTIES RUN ONLY TO ORIGINAL PURCHASER AS DESCRIBED ABOVE AND ARE NOT EXTENDED TO ANY THIRD PARTIES.

IN NO EVENT SHALL APC, ITS OFFICERS, DIRECTORS, AFFILIATES OR EMPLOYEES BE LIABLE FOR ANY FORM OF INDIRECT, SPECIAL, CONSEQUENTIAL OR PUNITIVE DAMAGES, ARISING OUT OF THE USE, SERVICE OR INSTALLATION, OF THE SURGE PROTECTOR PRODUCT, WHETHER SUCH DAMAGES ARISE IN CONTRACT OR TORT, IRRESPECTIVE OF FAULT, NEGLIGENCE OR STRICT LIABILITY OR WHETHER APC HAS BEEN ADVISED IN ADVANCE OF THE POSSIBILITY OF SUCH DAMAGES.
