## Appearance

This smart outdoor plug has two individual smart outlets, each with a control button to turn on or off the plug-in device and a LED to show you the current status. The System LED 🛜 changes color according to different status. See the explanation below:



Press and hold a control button for 10s to restore your smart outdoor plug to factory default settings.

# Set Up Your Smart Outdoor Plug

Follow the steps below to set up your smart outdoor plug via Kasa Smart app.

#### 1. Download and install Kasa app


Go to Google Play or the Apple App Store or scan the QR code below to download the Kasa app on your Android or iOS smartphone or tablet.



### 2. Log in or sign up with TP-Link ID


Open the app. Use your TP-Link ID to log in.




# **Configure Your Smart Outdoor Plug**




