They are never sent to outside via network nor used for any other purpose except for the purpose described the above. To disable the function, add the check mark for [Disable the automatic save function for management information history]

in [Hard Disk Status] of PC Information Viewer, and click [OK].

- To conserve power, the following power saving methods are set at the time of purchase.
