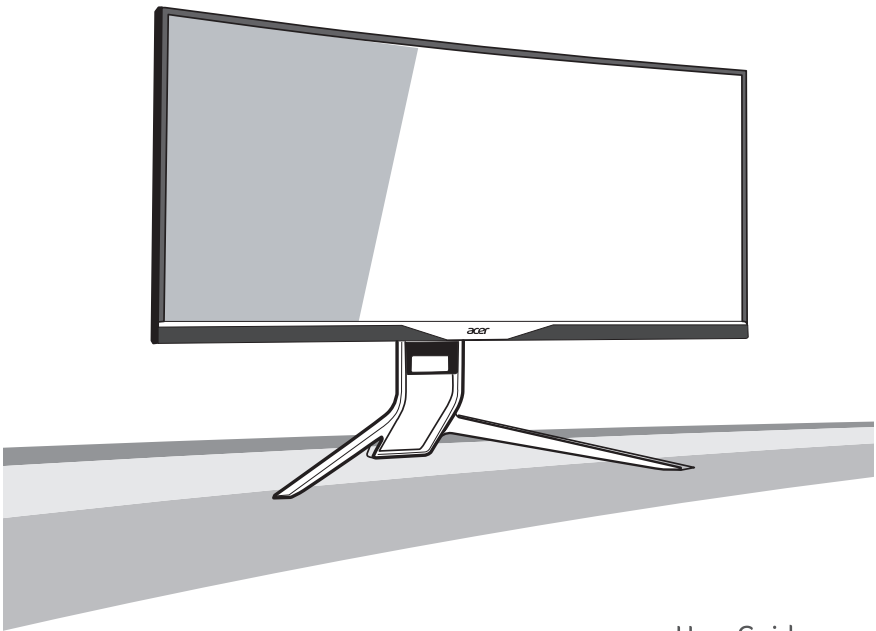

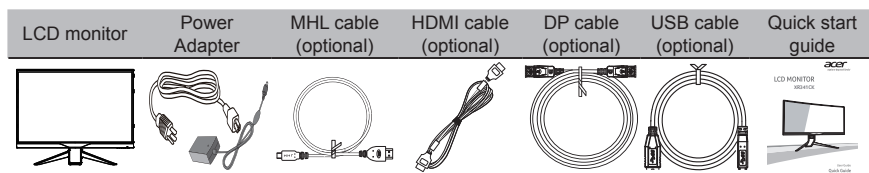
# Acer LCD Monitor Quick Start Guide (QSG)

## Important safety instructions

Please read the following instructions carefully.

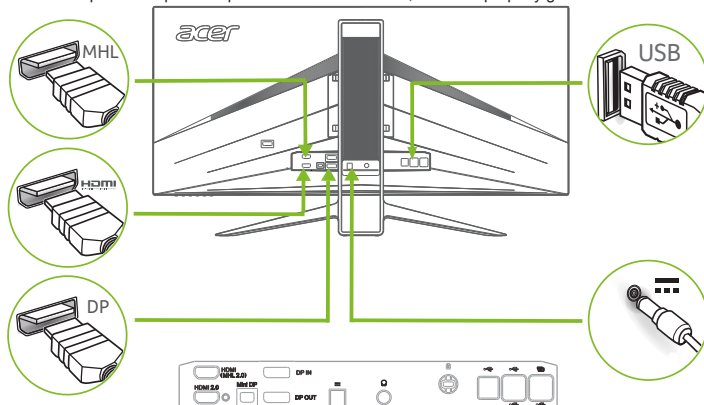
- To clean the LCD monitor screen:
  - Turn off the LCD monitor and unplug the power cord.
  - Spray a non-solvent cleaning solution onto a rag and clean the screen gently.
- Do not place the LCD monitor near a window. Exposing the monitor to rain, moisture or sunlight can severely damage it.
- Do not apply pressure to the LCD screen. Excessive pressure may cause permanent damage to the display.
- Do not remove the cover or attempt to service this unit yourself. An authorized technician should perform servicing of any nature.
- Store the LCD monitor in a room with a temperature of  $-20^{\circ}$  to  $60^{\circ}$  C ( $-4^{\circ}$  to  $140^{\circ}$  F). Storing the LCD monitor outside this range may result in permanent damage.
- Immediately unplug your monitor and call an authorized technician if any of the following circumstances occur:
  - Monitor-to-PC signal cable is frayed or damaged.
  - Liquid spills onto the LCD monitor or the monitor is exposed to rain.
  - The LCD monitor or case is damaged.
- In order to prevent damage to the LCD panel, do not place the monitor face down on a surface.

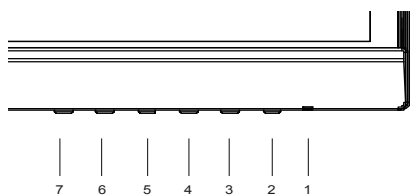

## Connecting your monitor to a computer

- Turn off your computer and unplug your computer's power cord.
- Connect the signal cable to the HDMI (optional) and /or DP (optional) and /or MHL (optional) input socket of the monitor, and the HDMI (optional) and /or DP (optional) and /or MHL (optional) output socket of the graphics card on the computer. Then tighten the thumbscrews on the signal cable connector.
- Connect the USB Cable(Optional)

- Insert the monitor power cable into the power port at the back of the monitor.
- Connect the power adapter and power cord to the monitor, then to a properly grounded AC outlet.

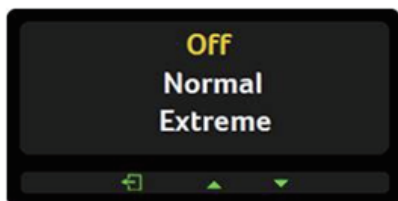

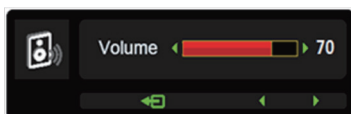
Open the OD control and select your preferred OD setting using the arrows. When you are done, use  to go back one level.

Open the Volume control and set the Volume using the arrows. When you are done, use

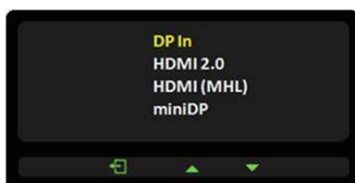

Open the Input control and select the Input using the arrows. When you are done, use

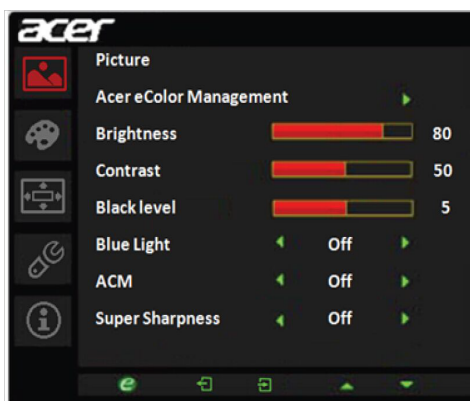

## The Function page

Open the Function page to adjust the Picture, Color, OSD and Setting functions, settings which you want using the arrows. You can also view your monitor's system information from this page. When you are done, use  to go back one level.

### Picture



1. Press the MENU key to open the OSD.
2. Using the ▲/▼ keys, select Picture from the OSD. Then navigate to the picture element you wish to adjust.

- Use the ◀/▶ keys to adjust the sliding scales.
- The Picture menu can be used to adjust the Acer eColor, Brightness, Contrast, Black Level, Blue Light, ACM and Super Sharpness.
- Brightness: Adjust the brightness from 0 to 100.



**Note:** Adjusts the balance between light and dark shades.

- Contrast: Adjust the contrast from 0 to 100.



**Note:** Sets the degree of difference between light and dark areas.

- Black Level: Adjust the black level from 0 to 10. Enhances shadows by increasing the brightness without changing lighter shades.



**Note:** If the image is very bright or has few shadow areas, adjusting this setting may not result in any noticeable changes to the image.

- Blue Light: Filters out blue light to protect your eyes by adjusting how much blue light is shown -- 80%, 70%, 60%, or 50%.



**Note:** Higher values allow more blue light through. For the best protection select a lower value.

- ACM: Turn ACM on or off. The default is off.
- Sharpness: Turn the sharpness On or Off. Sharpness technology can simulate high-resolution images by boosting the pixel density of the original source to make images sharper and clearer.

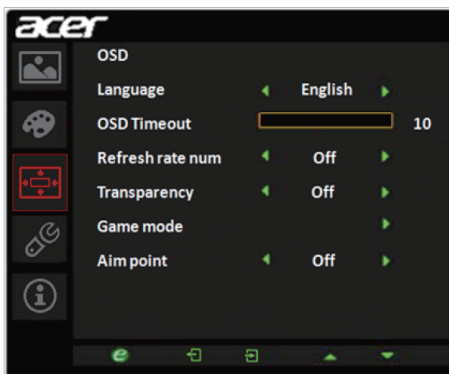
## Color



- Press the MENU key to open the OSD.
- Using the ▲/▼ keys, select Color from the OSD. Then navigate to the picture element you wish to adjust.
- Use the ◀/▶ keys to select the setting.

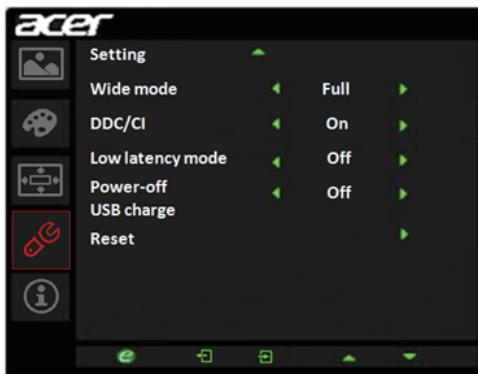
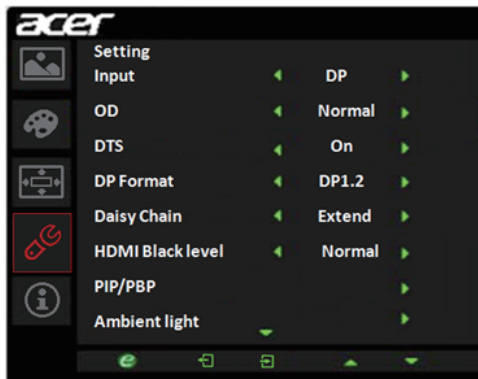
4. Gamma mode allows you to adjust the luminance tone. The default value is 2.2 (standard value for Windows).
5. Color temperature: Default is warm. You can choose Cool, Warm, Bluelight or User.
6. sRGB: Default is off. You can turn sRGB on or off to better color match with peripheral devices, such as printers and digital cameras.
7. 6-axis Saturate: Adjust the red, green, blue, yellow, magenta and cyan saturation.
8. 6-axis Hue: Adjust the red, green, blue, yellow, magenta and cyan hue.

## OSD




1. Press the MENU key to open the OSD.
2. Using the ▲/▼ keys, select OSD from the OSD. Then navigate to the setting you wish to change.
3. Use the ◀/▶ keys to adjust any sliding scales.
4. Language: Set the OSD menu language.
5. OSD timeout: Adjust the delay before turning off the OSD menu.
6. Refresh rate num: Display the panel's current refresh rate on the screen.
7. Transparency: Select the transparency when using gaming mode. The transparency can be 0% (OFF), 20%, 40%, 60%, or 80%.
8. Game mode: There are three user-defined profiles available. When you have decided what settings suit you, save them and system will be able to recall the settings in the future when you turn on gaming mode and press 1, 2 or 3.
9. Aim point: Show an Aim point on the screen for shooting games.

## Setting

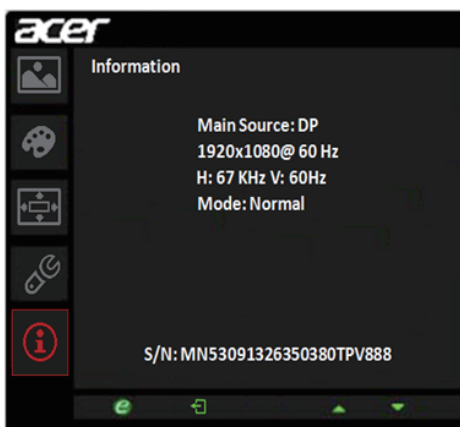


1. The Setting menu can be used to select the screen menu language and other important settings, including input and OD level.
2. Press the MENU key to open the OSD.
3. Using the ▲/▼ keys, select Setting from the OSD. Then navigate to the setting you wish to adjust.
4. Use the ◀/▶ keys to select the setting.
5. Input: Select the source from DP In, HDMI 2.0, HDMI(MHL), or miniDP.
6. OD: Select Off, Normal, or Extreme.
7. DTS: Turn DTS Sound On or Off. Your monitor is equipped with two 7W speakers on the rear. DTS Sound is stratified and creates a remarkable sonic flow.
8. DP Format :Default is DP1.2, can selection DP support DP1.1 or DP1.2 format.
9. Daisy Chain: Daisy Chain: Default is extend, can select daisy chain function extend or clone.
10. HDMI Black level setting
11. PIP/PBP settings



12. Ambient light: Adjust the lighting effects, color, and style.
13. Wide mode: You can select which screen aspect you are using. The options are Full, Aspect, and 1:1.
14. DDC/CI: Allows the monitor settings to be set through the software on the PC.
15.  **Note:** DDC/CI, short for Display Data Channel/Command Interface, which allows monitor controls to be sent via software.
16. Low latency mode: Select Off or On. Turn off to speed up boot speed.
17. Power-off USB charge: Turn On or Off.
18. Reset: Resets the custom color settings to the factory defaults.

2. Using the ▲/▼ keys, select Information to view the basic information for your monitor and current input.

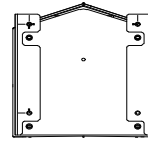
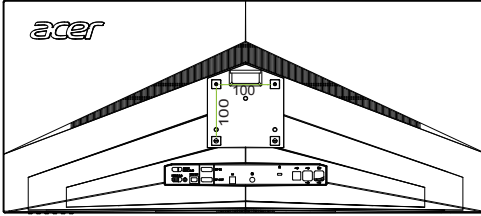

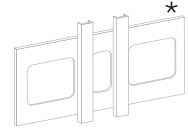

Wall mount BKT

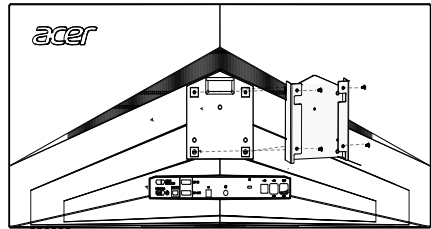
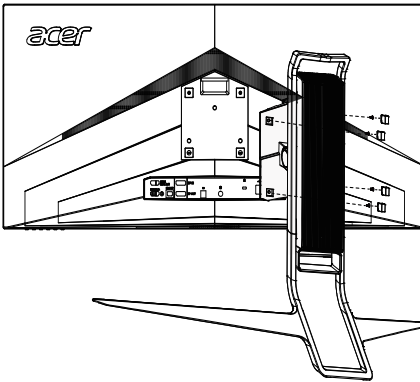

## Note:

- The LCD monitor shall only be used with an approved arm (e.g. GS mark).
- To meet the safety requirements, the monitor must be mounted to an arm that supports the weight of the monitor.
- This monitor supports the VESA industry standard 100 mm mounting holes.



## Note:

The monitor could be mounted to the wall through mounting bracket, the steps as below,

1. Remove the stand from the monitor, keep the four screws(M4\*10.0mm).
2. To attach the monitor to a mounting bracket (purchased separately)
  - 2.1. Attach the wall mount BKT with four M4\*8.0mm screws, tighten it to the back of the monitor;
  - 2.2. Attach the mounting bracket with four M4\*10.0mm screws, tighten it to the wall mount BKT.
