1 Appearance Description

The overview of the camera is shown below.




Figure 1-1 Overview of the Camera

Note:

- Hold RESET about 10s when the camera is powering on or rebooting to restore the default settings, including the user name, password, IP address, port No., etc.
- A wireless router with the WPS function is required to enable the WPS function of the camera. Refer the steps below.

Steps:

- 1) Press the WPS button on the router.
- Press the WPS button (about 2s) on the camera within 120s you enable the WPS of the router to join in the wireless network.

Note:

- The WPS button works as a reset button only when you press it when the camera is powering on.
- Press the WPS button on the camera, and then press the WPS button on the router will work as well, and the expire time of WPS connection on the camera is 120s.

2 Installation

Before you start:

- Make sure the device in the package is in good condition and all the assembly parts are included.
- The standard power supply is 12 VDC. Make sure your power supply matches with your camera.
- Make sure all the related equipment is power-off during the installation.
- Check the specification of the products for the installation environment.
- Make sure that the wall is strong enough to withstand four times the weight of the camera and the bracket.

For the camera that supports IR, you are required to pay attention to the following precaution to prevent IR reflection:

- Dust or grease on the dome cover will cause IR reflection.
 Please do not remove the dome cover film until the installation is finished. If there is dust or grease on the dome cover, clean the dome cover with clean soft cloth and isopropyl alcohol.
- Make sure that there is no reflective surface too close to the camera lens. The IR light from the camera may reflect back into the lens causing reflection.
- The foam ring around the lens must be seated flush against the inner surface of the bubble to isolate the lens from the IR LEDS.
 Fasten the dome cover to camera body so that the foam ring and the dome cover are attached seamlessly.

2.1 Camera Mounting

2.1.1 Wi-Fi Antenna Mounting

Steps:

1. Screw up the Wi-Fi antenna as shown in the figure below.



Figure 2-1 Mount the Wi-Fi Antenna

2. Tighten the locking nut using the supplied wrench.

2.1.2 Ceiling Mounting

Make sure the Wi-Fi antenna has been installed before the ceiling mounting.

Steps:

1. Install the adapter plate to the ceiling with screws.




Figure 2-2 Install the Adapter Plate to the Ceiling

- If you need to route cables through the ceiling, cut a cable hole on the ceiling. Skip this step if you want to route the cables on the surface of the ceiling.
- Route the cables of the camera.
- Hold the bottom base and rotate the camera according to the marked direction on the adapter plate until it clicks into place.

5. Adjust the view angle.

- Loosen the three base screws with the supplied wrench to remove the bubble.
- 2). Loosen the tilt adjusting screws.
- Adjust the camera view angle in panning and tilting directions.
 The angle range of the pan direction is 0° to 355°, and the angle range of the tilt direction is 0° to 75°.
- 4). Tighten the tilt adjusting screws.
- 5). Tighten the base screws to replace the bubble.




Figure 2-4 Adjust the View Angle

2.1.3 Ceiling Mounting with Bracket

Before you start:

The ceiling mounting bracket is not included in the package. You need to purchase the ceiling mount bracket separately. Make sure the Wi-Fi antenna has been installed before the ceiling mounting.

Steps:

1. Install the bracket to the ceiling with the self-tapping screws.




Figure 2-5 Secure the Bracket

2. Secure the adapter to the bracket with screws.

- If you need to route cables through the ceiling, cut a cable hole on the ceiling. Skip this step if you want to route the cables on the surface of the ceiling.
- 4. Route the cables of the camera.
- Hold the bottom base and rotate the camera according to the marked direction on the adapter plate until it clicks into place.

Adjust the view angle. For the detailed information, refer to step 6 in 2.1.2 Ceiling Mounting.

2.2 Installation of Network Cable Water-proof Jacket (Optional)

Purpose:

If the camera is installed outdoor, you can adapt the water-proof accessory for the network cable after the camera is secured on the installation surface.

1	Camera's Network Interface Socket
2	O-Type Gasket
3	Network Plug
4	Waterproof Endcap
5	Waterproof Rubber Gasket
6	Lock Nut
7	Network Cable from Router/Switch

Steps:

- Feed the plugless network cable ① through the lock nut ⑥, waterproof rubber gasket ⑤ (the rubber gasket inset ridge must face the waterproof endcap), and the waterproof endcap ④ in order.
- Crimp an RJ-45 network plug 3 onto the end of the cable, taking care to insert the twisted pairs of wires in correct order.
- Place the O-type gasket ② onto the end of the camera's network interface socket ①.
- Insert the network plug 3 into the camera's network interface socket 1.

- Insert the waterproof rubber gasket (§) into the waterproof endcap (4), and secure lock nut (6) with the waterproof endcap (4).
- 6) Align the snap on the waterproof endcap (4) with the notch on the camera's network interface socket (1), and then secure the waterproof endcap (4) to the camera's network interface socket (1) to finish installation.




Figure 2-9 Water-proof Accessory Installation

3 Setting the Network Camera over the LAN

Note:

- If the camera is used with a Wi-Fi NVR that can work as a
 wireless network router, the camera can connect to the NVR's
 Wi-Fi automatically after the camera is powered on. You can
 activate, add and configure the camera on the NVR. Make sure
 the NVR's Wi-Fi has been configured in advance. Refer to Quick
 Start Guide of Network Video Recorder for details.
- You shall acknowledge that the use of the product with Internet access might be under network security risks. For avoidance of any network attacks and information leakage, please strengthen your own protection.
- If the product does not work properly, contact your dealer or the nearest service center for help.

3.1 Wiring

Connect the camera to network according to the following figures.

3.2 Activating the Camera

You are required to activate the camera first by setting a strong password for it before you can use the camera.

Activation via Web Browser, Activation via SADP, and Activation via Client Software are all supported. We will take activation via SADP software and Activation via Web Browser as examples to introduce the camera activation.

Note:

Refer to the *User Manual of Network Camera* for Activation via Client Software.

3.2.1 Activation via Web Browser

Steps:

- Power on the camera. Connect the camera to your computer or the switch/router which your computer connects to.
- Input the IP address into the address bar of the web browser, and press Enter to enter the activation interface.

Notes:

- The default IP address of the camera is 192.168.1.64.
- The computer and the camera should belong to the same subnet.
- For the camera enables the DHCP by default, you need to use the SADP software to search the IP address.

Create a password and input the password into the password field.



STRONG PASSWORD RECOMMENDED—We highly recommend you create a strong password of your own choosing (using a minimum of 8 characters, including upper case letters, lower case letters, numbers, and special characters) in order to increase the security of your product. And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.

- 4. Confirm the password.
- 5. Click **OK** to save the password and enter the live view interface.

3.2.2 Activation via SADP Software

SADP software is used for detecting the online device, activating the camera, and resetting the password.

Get the SADP software from the supplied disk or the official website, and install the SADP according to the prompts.

Follow the steps to activate the camera.

Steps:

- Run the SADP software to search the online devices.
- Check the device status from the device list, and select the inactive device.

Note:

The SADP software supports activating the camera in batch. Refer to the user manual of SADP software for details.

Create and input the new password in the password field, and confirm the password.

Note:

You can enable the Hik-Connect service for the device during activation. Refer to Chapter 5.1 for detailed information.

4. Click Activate to start activation.

You can check whether the activation is completed on the popup window. If activation failed, make sure that the password meets the requirement and try again.

3.3 Modifying the IP Address

Purpose:

To view and configure the camera via LAN (Local Area Network), you need to connect the network camera in the same subnet with your PC.

Use the SADP software or client software to search and change the IP address of the device. We take modifying the IP Address via SADP software as an example to introduce the IP address modification.

For IP address modification via client software, refer to the user manual of client software.

Steps:

- 1. Run the SADP software.
- 2. Select an active device.
- Change the device IP address to the same subnet with your computer by either modifying the IP address manually or checking the checkbox of Enable DHCP.

Note:

You can enable the Hik-Connect service for the device during activation. Refer to Chapter 5.1 for detailed information.

 Input the admin password and click Modify to activate your IP address modification.

The batch IP address modification is supported by the SADP. Refer to the user manual of SADP for details.

4 Accessing via Web Browser

System Requirement:

Operating System: Microsoft Windows XP SP1 and above version

CPU: 2.0 GHz or higher

RAM: 1G or higher

Display: 1024×768 resolution or higher

 Web Browser: Internet Explorer 8.0 and above version, Apple Safari 5.0.2 and above version, Mozilla Firefox 5.0 and above version and Google Chrome 18 and above version

Steps:

- 1. Open the web browser.
- In the browser address bar, input the IP address of the network camera, and press the Enter key to enter the login interface.

Note:

The default IP address is 192.168.1.64. You are recommended to change the IP address to the same subnet with your computer.

3. Input the user name and password.

The admin user should configure the device accounts and user/operator permissions properly. Delete the unnecessary accounts and user/operator permissions.

Note:

The device IP address gets locked if the admin user performs 7 failed password attempts (5 attempts for the user/operator).

4. Click Login.

Install the plug-in before viewing the live video and managing the camera. Follow the installation prompts to install the plug-in.

Note:

You may have to close the web browser to finish the installation of the plug-in.

5 Operating via Hik-Connect App

Purpose:

Hik-Connect is an application for mobile devices. With the App, you can view live image of the camera, receive alarm notification and so on.

Note:

Hik-Connect service is not supported by certain camera models.

5.1 Enable Hik-Connect Service on Camera

Purpose:

Hik-Connect service should be enabled on your camera before using the service.

You can enable the service through SADP software or web browser.

5.1.1 Enable Hik-Connect Service via SADP Software Steps:

- 1. Check the checkbox of Enable Hik-Connect on:
 - "Activate the Device" page during camera activation, refer to Chapter 3.2.2.
 - Or "Modify Network Parameters" page during modifying IP address, refer to Chapter 3.3.
- 2. Create a verification code or change the verification code.




Figure 5-1 Verification Code Setting (SADP)

Note:

The verification code is required when you add the camera to Hik-Connect app.

- 3. Click and read "Terms of Service" and "Privacy Policy".
- 4. Confirm the settings.

5.1.2 Enable Hik-Connect Service via Web Browser Before you start:

You need to activate the camera before enabling the service. Refer to Chapter 3.2.

Steps:

- Access the camera via web browser. Refer to Chapter 4.
- Enter platform access configuration interface: Configuration > Network > Advanced Settings > Platform Access

- 3. Select Platform Access Mode as Hik-Connect.
- 4. Check the checkbox of Enable.
- Click and read "Terms of Service" and "Privacy Policy" in pop-up window.
- Create a verification code or change the verification code for the camera.

Note:

The verification code is required when you add the camera to Hik-Connect app.

7. Save the settings.

5.2 Hik-Connect Setup

Steps:

- Download and install the Hik-Connect app by searching "Hik-Connect" in App Store or Google PlayTM.
- 2. Launch the app and register for a Hik-Connect user account.
- 3. Log in Hik-Connect app after registration.

5.3 Adding Camera to Hik-Connect

Before you start:

You need to enable the Hik-Connect service on camera before adding it to your Hik-Connect account. Refer to Chapter 5.1.

Steps:

 Use a network cable to connect the camera with a router if the camera does not support Wi-Fi.

Note:

After the camera connects to the network, please wait one minute before any operation on the camera using Hik-Connect app.

In the Hik-Connect app, tap "+" on the upper-right corner and then scan the QR code of the camera to add the camera.

You can find the QR code on the camera or on the cover of the Quick Start Guide of the camera in the package.

Note:

If the QR code is missing or too blur to be recognized, you can also add the camera by tapping the icon and inputting the camera's serial number.

3. Input the verification code of your camera.

Note:

- The required verification code is the code you create or change when you enabling Hik-Connect service on camera.
- If you forget the verification code, you can check the current verification code on Platform Access configuration page via web browser.
- Follow the prompts to set the network connection and add the camera to your Hik-Connect account.

Note:

For detailed information, refer to the user manual of the Hik-Connect app.

5.4 Initializing the Memory Card

Note:

The memory card is only supported by certain models. See the actual device for details.

Steps:

Check the memory card status by tapping on the Storage Status in the Device Settings interface.

If the memory card status displays as Uninitialized, tap to initialize it. The status will then change to Normal. You can then start recording any event triggered video in the camera such as motion detection.
